One of the seven men charged over the September 2009 murder of businessman Michael McGurk could be granted immunity under a deal being sought by the Director of Public Prosecutions when the accused men's defence lawyers appeared in Central Local Court on Tuesday. "Acting for the crown, Mark Hobart SC told the court the DPP would apply to Attorney-General Greg Smith for "indemnity", also known as immunity, from prosecution," The Australian reported, "Defendants are granted indemnity for such reasons as giving evidence against their co-accused." The accused are due back on court this March.

Meanwhile, the defence lawyers for prominent Perth barrister Lloyd Rayney are feeling the pressure of the five-month trial the accused Rayney will face for the murder of his wife. "(They) say there is a 'serious danger' they will not be ready for his May murder trial because of the huge amount of material involved in the case," reported The Australian. Rayney's lawyer, Tony Elliott, expressed to the Supreme Court commissioner his concern that the defence team had not received all relevant material in the case and that the prosecution should have disclosed evidence more promptly.
