Personal injury involves not only being harmed physically but it also includes harm over the mental well being of a person. Moreover, to arrive at the final amount that has to be paid for compensation necessary obligations also need to be considered by the injured. Give all the relevant information related to the accident to the police, make a note of the names and addresses of the relevant parties and witnesses to the accident. Various people need to be informed like your insurance company, employer, school or college soon after the incident. Maintain a record of all expenses including the time spent by the family members in taking care of the injured. Likewise, you should also check out if any other insurance coverage route is available to you in view of a personal injury.
