A business litigation lawyer represents the business of his/her clients in federal or state court. In simple term, a lawyer having proper and in-depth knowledge about undertaking the business related issues is known as business litigation lawyer. Attorney tends to be specialized in filing lawsuits, respond lawsuits and follow all the litigation process on the behalf of clients.

Different phases of proceedings:

The complete litigation process comprises of the several phases ranging from filing petition to making appeal in appellate court. An experienced attorney would be adept in managing all these individual phases properly to bring the outcome in favor of clients.

â€¢ Pleading phase - Pleading or petition refers to the process of making or filing complaint in court. Here the lawyer prepares document consisting of the reason of filing lawsuit including the expected remedy of the case. However, the substantive part issue is that all matters and contents of document must meet the requirement of qualified petition.

â€¢ Search and respond â€” The business litigation lawyer initiates with searching the imperative content and facts that can strengthen their point in court. This is the phase where lawyers from both sides get engaged in responding to the lawsuits with the proper facts and exemplary evidences that they compile through the painstaking search. The methods of accumulating the facts could be whether interviewing with the other parties, asking questions, or taking witnesses in depositions. Utilizing all the methods both lawyers input their best efforts to collect vital facts related to their case.

â€¢ Trails - This is the phase which comes usually after the failure of negotiation round. Here the lawyer has to draft a document containing concise and vital details related to case as it would be presented to the jury. Thus, an attorney must be updated with all requisites of qualified trail document.

Different roles of litigation attorney:

There are numerous roles performed by litigation lawyer during the proceedings of lawsuits.

ïƒ Filing â€” At the time of filing lawsuits, the business attorney assists their clients to determine what contents should be there in document which comply with all standards of qualified petition otherwise the opposing party would take advantage. Moreover, the case will be thrown out of the court without legit reason of filing pleading.

ïƒ Response â€” A lawyer has to respond lawsuits in state or federal court with proper facts after examining the case details

ïƒ Representation â€” A lawyer represents his/her clients in court room. In addition with, they answer the questions asked in court room on the behalf of their clients. This is the biggest role that an attorney performs and let the clients monitor the case properly.

ïƒ Negotiation - Most of the cases are settled in the negotiation phase. Here the role of the both sidesâ€™ lawyers is to settle the dispute coming to the consensus point of settlement. The settlement point must be agreed by both parties to end up the lawsuit.

These all are the roles and responsibilities of business litigation lawyer during assisting their clients.
