The primary detail you need to do is check if anybody in the accident scene is wounded, and if it is the driver of another vehicle or a passerby. Seek medical attention for yourself and the other injured parties. If the scene is too distant from a hospital and no vehicle in the area can carry the hurt people, call the cops immediately as they quite often respond with a medical crew. Nonetheless, for the time being, look for a person who knows first aid.

Exchange personal information with the individuals involved in the accident. This will speed up the police report as soon as the authorities arrive. Call your attorney and explain what happened. Your legal counsel knows what to do to enable you to stay away from any culpability, particularly if no one in the accident scene knows the specific circumstance of the accident. Do not apologize or admit your fault before you are told of your attorney's advice. If he cannot deal with the suit, he can endorse you to a motorcycle accident attorney.

If you have a camera with you, take photos of the scene before anybody begins to shift the automobiles involved. The police can piece those photos collectively to work out what took place.
