The Zadroga Claim is linked with the terrorist attack at the World Trade Attack Centre on September 9th, 2001. Thus, it is filled by those groups of people who have suffered bodily and emotional health setbacks during the World Trade Centre Attack.

The Zadroga Claim would help the sufferers get monetary benefits on getting infected with high amount of respiratory disorder and serious health condition such as Upper or Lower Airway Disease, Acid Reflux Disease, occupational asthma, Sarcoidosis, Asbestosis, Mesothelioma Cancer.

Mesothelioma is a form of cancer which affects the chest, abdominal cavity and area around the heart. The people affected by these are those who have closely worked on jobs where they have inhaled Asbestos. Asbestos is found in building material, construction site, etc.

In January 2011, the government of United States issued the Zadroga Law under which all the volunteers, police personnel, fire workers, etc. who helped in the rescue operation at the World Trade Centre Attack are eligible to file for the Zadroga Claim.

The 9/11 Health and Compensation fund provides some amount of financial relief to the individuals who had faced severe medical problems during the WTC attack. An efficient Zadroga Lawyer should go through the complete situation of the case and should then take actions accordingly.
