Losing valuable computer file that you require for your work, accidentally through careless use of delete key or corruption can be a real stressful experience. But thankfully there is way to retrieve the lost data and salvage the situation. File recovery utility provides the much coveted medium that can be used to store your important business documents and restore them if there is a data loss incident. This kind of file recovery software is programmed to conduct backup of the computer data at regular intervals and recreate any lost file within a short span of time.

File recovery utility to restore deleted file

Computer data after being deleted is usually relegated to the Recycle Bin (if it's a Windows Operating System) or Trash (in case of Mac) folder. In that case you need to search those particular folders to check if the file is still there. If the file is there you need to drag it to the desktop and then return it to its original location by clicking on the file and then restoring it. But in case the file is not found in the Recycle Bin or the Trash use a file recovery utility that will scan your computer's hard drive for recognizable data. When a file is deleted, the operating system typically does not erase the actual bits from the hard drive, making it possible for you to recover some data.

However make sure that the file recovery utility is not installed on the same disk that you are planning to reclaim the file from. Or else you will run the risk of overwriting the data you're trying to restore. Use a CD-ROM or a floppy disk to lodge the software. And if you wish to get it downloaded straight from the internet, don't launch it onto the disk from which the file has been deleted.

File recovery utility to recover data from damaged disk

File recovery utility (http://www.intelinet-systems.com/image_backup.aspx) needs support from disk-repair utility that comes with the computer operating system to reconstruct the data which has been lost due to disk crash. But it must be clearly understood that commercial disk-repair utility needs to be installed before you experience the crash for the software to work optimally. However if the disk is found to be irreparable and that data is valuable enough for you to shell out some big bucks, you can consider taking the help of specialty data recovery service. The service provider will disassemble the drive and use an advanced file recovery utility to recover as much data as possible.

Every organization appreciates the importance of data backup for future reference or for any other use. And it is therefore absolutely essential to deploy a suitable file recovery utility to handle any crisis situation related to data loss. Don't assume that your hard drive will never crash or your files will never be deleted by mistake. And on such event the value of the lost data will necessarily be much more than the cost of deploying recovery utility with better coverage. So shed your inhibition and buy data restoration software that suits your budget and purpose.
