Australia is a country that attracts lot of tourists from all over the world. There are many tourists who also look for work opportunities in foreign countries that they are visiting in order to meet with their travel cost. Australia is one such country that offers Australian working holiday visas that help its holder to take the work opportunities available in the country.

The reason why tourists opt for Australian holiday working visa is that it not only offers the holder to take the work opportunities but also makes them eligible to apply for second Australian visa holiday and increase their stay in Australia. If you want to get Australian holiday working visa successfully it is very important that you know the eligibilities, rules and regulations related to this visa.

Eligibilities:

Working holiday visa program is provided to those applicants only who are between 18 and 30 years of age without having any dependent children, passport holders of the countries that reciprocate the program and the passport must have one year till renewal, applicants visiting Australia only for the purpose of holidaying and work undertaken for financial support only and lastly must show proper documents to prove that the applicant has adequate fund to support their initial stay in Australia.

Secondly, Australian holiday working visa must be applied overseas i.e., outside Australia. In case of applying for second Australian working holiday visa it can be applied from Australia.

Thirdly, applicants for this type of Australian working visa must go for medical test or provide necessary documents to show that he or she is fit to travel to Australia.

Financial Requirements for Australian Working Holiday Visa

You must remember that there is a financial requirement for Australian holiday working visa. Applicant is required to have access to adequate funds in order to support themselves for their initial stay of their holiday in Australia. Applicants might be asked to show evidence of access to proper funds on their arrival to immigration officials.

According to the Department of Immigration and Citizenship the sufficient amount is minimum of AUD\$5,000. However, this amount might vary depending on the tenure of the stay and how much travelling the applicant intends to do. The applicant must have either a return or onward ticket or the funds at least for the fare to depart Australia, if travelling on one way ticket.

Applicant might need to provide certified bank statement copy and plane ticket out of Australia.

Working and Staying with Australian Working Holiday Visa

Holders of Australian working holiday visas have 12 months to travel to the country starting from the approval date. One can stay for 12 months in Australia from the date entered in the country. One can enter or leave Australia within this period. However, it is important to remember that time period spent outside Australia cannot be recovered.

These visa holders will be engaged in specified work. Specified work includes work in different sectors like plant and animal cultivation, tree framing, fishing, construction work and mining. Please
