Australia is a country that attracts tourists from every corner of the world. If you are planning to visit Australia you must be aware of the fact that you need a visa to visit this place. As Australia offers different types of visas, it might be a bit confusing in choosing the right one. However, opting for work holiday visa would be a great option as it has lot of benefits to the holders. Let's take a look at the benefits of Australian working holiday visa.

One of the first and foremost benefits of choosing this Australian work visa is it allows the holders to take the work opportunity available in Australian primary sector. Thus, it helps the holder to enjoy the beauty of Australia without worrying too much about the expenses related to travel.

The second benefit of Australian working holiday visa is it provides the holder the opportunity to apply for second Australian working holiday visa after the applicant has worked as a specified worker in Australia for a minimum period of three months. While applying for second work holiday visas one can extend their trip from 12 months to 24 months. Thus, if you wish to apply for Australian working holiday visa, it is very important to know about eligibilities and requirements related to it so that you can acquire the visa successfully.

Let's take a look at the basic requirements for Australian working holiday visa. The applicant must be aged between 18 and 30 years old without any dependent children. Secondly, the applicant must be a passport holder of an eligible country and must have one year until the renewal of passport. The applicant must be going to Australia for the purpose of holidaying only and any work undertaken during visit to Australia is for the purpose of financial support only. Lastly, the applicant must provide necessary documents to show adequate funds to support for the initial part of their stay. This might include certified copy of bank statement and air ticket out of Australia.

While applying for working holiday visas Australia one must apply overseas, which means at the time of application the applicant must be outside Australia. Only in case of applying second Australian working holiday visa the concerned applicant can apply from Australia.

Other than these requirements the applicant must remember that there are health and character requirements. The applicant must provide with necessary medical certificates and they must also be prepared to undergo formal health examinations. This aspect becomes an important issue if the applicant wishes to work in Australian health care industry.

With Australian working holiday visa the holder can stay up to 12 months from the date of visa granted and it allows the holder to re-enter Australia during this time period. Holders will have work opportunity in the primary sector of Australia and will be employed as specified worker. One can get specified work in plant and animal cultivation, fishing and pearling, tree farming and feeling, mining, construction.
