For the past few years, Australia has emerged as one of the most popular destinations for highly skilled young people. The economy of Australia is quite stable and the country actively encourages the immigration of the skilled migrants.

If one is wishing to work in Australia the applicant must apply for skilled or work visa. Some of the basic requirements for applying Australian work permit includes that the applicant must be at least 18 years old and should not be over 45 years of age. The applicant must be able to speak sufficient English and must pass the Skilled Visa points test followed by character and health requirements.

One of the important way to qualify for Australian work permit is the applicant's skills and qualifications must meet the Australian standards under SOL or Skilled Occupational List. He or she must have minimum of 12 month employment of the skill for which the applicant is applying.

The concerned applicants must keep in mind that they have positive skill assessment from relevant assessing authority for the occupation they are applying for. As of July 1 2008 all the applicants must lodge their respective application to ASPC or Adelaide Skilled Processing Centre. For online and onshore General Skilled Visa applicants they must lodge their application at BSPC or Brisbane Skilled Processing Centre.

Some of the other requirement for applicant of Australian work permit includes filling up of several form including Application for General Skilled Migration to Australia, details of any dependent member of the family and signing an Australian Value Statement.

There are different types of Australian work visas are available like skilled independent visa, skilled sponsored visa, skilled regional sponsored visa, temporary business visa, employer nomination scheme visa, working holiday visas and work and holiday visa.

Young holiday makers who are looking forward to visit Australia can opt for Australian working holiday visa that provides them with the opportunity to opt for short-term and casual opportunities to take care of their travel expense.

If the applicant wants to qualify for this visa he or she must meet the specific requirements that includes being between 18 and 30 years of age and hold passport from country that offers reciprocal working holiday program. They must also meet with other requirements that include meeting health, character and financial requirements.

After the visa is approved the applicant becomes eligible for entering Australia for 12 months from the approval date. During this period the visa holder can re enter Australia. Australian working holiday visa holders have the permission to work for any employer for a period of six months. They can also undertake any training or study but for a maximum period of four months. After one has done at least three months of seasonal work in regional Australia, one becomes eligible for applying second Australian work holiday visa. The types of work available with this Australian work visas are in the primary sector that include fishing and pearling, tree farming and felling, mining and construction.
