You can also clear your doubts by visiting the FAQ section of the website. The main advantage of contacting reputed solicitors from Ireland is that you can request for a free case assessment. This way the solicitor can assess your options and likelihood of success. You will be surprised by the outcome.

To initiate claims enquiry, you just need to fill up a simple online form with information like your name, address, contact numbers,. Besides, you have to give important particulars like date, time and type of accident, loss or injury incurred and all other related information.
