Being citizens of our country it is mandatory for us to pay taxes because the amount of funds collected by the government by way of taxes is used for the welfare of all people. The government uses these resources for the overall development of the country as well as its citizens. In fact tax is a compulsory payment which the citizens of a nation are bound to pay but there are many people who always try to evade taxes. In order to reduce the burden of its citizens the government of different nations provides various types of tax exemptions. One of such tax exemptions are Uniform Tax allowance or Uniform Tax Deduction.

There are many work places which have uniforms for their employees. In fact different work places have different types of uniforms. The government provides Uniform Tax Allowance on uniforms. However, all uniforms are not applicable for this allowance, only the uniforms which have been defined by the government in its law book. In order to get Uniform Tax Deduction the employer is required to register the uniform of his company in the law book of the government. Then it is approved by the governing authority. Once it is approved the uniform is placed under the compulsory slab under which tax deduction can be availed.

The government provides compensation for the amounts spend on the buying, washing, repairing and maintaining the uniform. In fact items such as safety helmets, rubber boots etc. are included in the uniform applicable for Uniform Tax Allowance because they are considered as protective clothing. However, there are some conditions that need to be fulfilled in order to get the tax exemption. The conditions are that the uniform should not be worn outside the work place and must have the logo of the company. Further, the employees working in different work grades have different exemption rates; therefore, it is very important for the employees to know the work grade they belong to in order to avail the benefit of tax deduction with regards to uniform.

If you want to get the Uniform Tax Deduction then you must have all the documents like bills and receipts of buying, washing, repairing as well as maintaining the uniforms because you will need them as proof while applying for the tax exemption.
