You have been injured in an automobile accident—now what? The Fort Lauderdale accident and injury attorneys at Lyons, Snyder & Collin, P.A. have the experience to answer all questions related to your automobile accident.

After seeking prompt medical attention (especially for medical emergencies such as: head injuries, symptoms of numbing/tingling/loss of feeling in extremities, or potentially broken bones) and contacting the police to securing a police report, you should immediately contact a law firm specializing in personal injury litigation.

Even in cases where you only incurred "seemingly minor injuries" you should seek a free consultation from an accident and injury attorney. Oftentimes, auto accident injuries may not be apparent to you right away (especially lower/middle back injuries and other soft tissue injuries) due to the adrenaline rush that takes over your body after an accident. An experienced accident attorney can help you secure the proper medical provider (i.e. neurologist, chiropractor, orthopedic surgeon) based on your injury / accident and medical insurance (or lack of medical insurance). Time is of the essence — insurance companies routinely limit and/or deny claims for individuals who do not promptly seek medical treatment.

Speaking of insurance companies, it is important to remember not to give a statement to the insurance company's representative about the car accident without first speaking with an experienced Personal Injury Attorney Fort Lauderdale. The information you provide to an insurance company can potentially cripple your case and limit your financial recovery. An auto accident attorney familiar with insurance companies (and their deceptive questioning) can help you navigate through their questions when reporting a claim and sitting for an independent medical examination (IME).

When retaining an accident attorney to represent your best interests and obtain the maximum compensation for your injuries, it is important to seek out an attorney with the highest level of credentials, reviews, trial experience, and someone you will trust will investigate all sources of recovery (i.e. "pockets") to make you financially whole. Do not simply settle for a "volume mill" you heard in a radio jingle that burns through thousands of clients per year. Commonly, an experienced personal injury attorney will seek monies from numerous sources including — all owners of the vehicle, employers, and possibly your own insurance company via uninsured or underinsured motorist coverage.
