But people often drive carelessly these days which results in accident. Some major accidents also lead to deaths. If the careless driving of someone leads to a dangerous accident causing death, legal action can be taken against the driver.

Workplace Accident: One of the major responsibilities of an employer is the safety of his or her employees. If an employee dies while working due to inadequate safety measures, the employer can be held responsible for the employee's death and can be sued.
