What is property tax?

Property tax is paid by the owner for his property. The tax is levied by the govt. authorities of the jurisdiction where the property is found. Property taxes are paid to an a national government, federated state, a municipality or the region.

How to pay :-

To pay the property tax online the user needs to follow the link “ <http://goo.gl/2MUzh>.”

The link can lead the user to the most page of all the govt. connected services of Kolkata Municipal Corporation.

The online tax payment links which can be given on the proper facet of the page will have numerous choices. The user needs to click on the relevant link.

Click on the create online payment link which can any provide you with several choices.

Select the type of “property tax” which is given to you in three choices.

If you are filing your property tax for the primary time, click on the contemporary supplementary link and fill within the needed info just like the individual number, contact number and therefore the email id. Once all the knowledge is crammed, the user needs to click on the pay button.

This applies to the payer’s who has already paid earlier and he needs to fill within the needed details or fetch it from the previous payments by clicking the payment button.

To get the whole details of the property in Kolkata, the user needs to click on the link stating; “fill up property info form” that is on the left facet of the page or click the button stating “details” and proceed with the payment.

To fill directly within the property info form, the user needs to follow the below link <http://goo.gl/jg48X>.

Get the printout of the unpaid bill, by clicking on the button stating "print unpaid bill".

To check the tax payment standing, the user needs to click on the button stating "check payment methods" that is on the left facet of the page.

Once the user has crammed within the needed details within the apt page, he will precede with the payment choice and therefore the tax payment on-line is completed.

Property tax abbreviations

PD Bill: Periodic Demand bills, that are issued annually, based mostly on the last set valuation of the residential property in Kolkata.

F/S Bill: Fresh/Supplementary bills, that are issued immediately when a hearing to mirror any changes to the sooner issued bills. Recent bills also are issued when the prime evaluation of a property in Kolkata.

LOI: Letter of Intimation is issued against the outstanding tax bills (PD or/and F/S). LOI contains the subsequent tax bills: 1. All unpaid F/S bills which is a magnet for penalty. 2. All unpaid PD bills that were issued before this fiscal year Such outstanding bills will solely be paid against the LOI.

Positive sides of online Payment

The online -payment facility in Kolkata makes it comfortable for the user to pay the tax on-line using the credit or the debit card.

The website not simply caters the services of paying the tax however additionally helps the citizens to download demand with hearing notices and lodge public grievances and complaints.

If the user has a problem in understanding, he/she will merely click on the tab with Bengali font on the Kolkata Municipal Corporation page.
