Beating a DUI charge takes more than just luck. It takes an experienced lawyer to beat the charges. It requires a cop attempting to use a breathalyzer that has yet to be screened for accuracy, and it takes just a little bit of chance to beat the rap. If you're caught drinking and driving, you're going to want to prepare yourself for the treacherous journey ahead of you that may include jail time, probation and a few hours of community service to clear your name. You'II need to prepare for what possibilities lie ahead.

Hiring a Decent Lawyer

Before you can ever get the charges dropped or reduced to a DWI, you'II need someone who knows how to handle the system. You cannot hire any old defense attorney without running the risk of losing the case. You need a specialist. You need an attorney conversant in how DUI laws work and skilled at getting charges reduced or thrown out completely. What you need is, simply, a DUI attorney.

A DUI attorney will focus solely on your case and use the knowledge of DUI laws within your state to help convince the judge to either reduce or drop the charges altogether. When finding a DUI attorney, it's best to look in your area for one. For example, if you were arrested in Orange County, you'II need to search for a Newport Beach DUI lawyer or one in a neighboring city. You must be sure to hire an attorney in your county. If not, you could risk losing the case because an attorney may not be familiar with county regulations outside of his or her area.

Hope You're At the Legal Limit

When an officer arrests you, he'II conduct three field sobriety tests to check if you're under the influence, after which he'II bring you down to the station and have an expert issue a medical exam. Here's where the luck comes in: if you're found over the .08% legal limit, little can be done by an attorney other than plead clemency. If you're at the .08%, then you have a chance at pleading for a DWI. If you plead for a DWI, you'II still be hit with the fines, but avoid a suspended license and breathalyzer installation in your car.

Pray for a Breathalyzer Exam

If given a choice of which chemical exam you wish to take, always go with the breathalyzer. Here's why: if you choose blood or a urine test, the medical professional will ensure with 100% accuracy that the blood or urine is yours and that you are guilty of a DUI. If you choose a breathalyzer, you have a slight chance of beating the charges because of the likelihood that the test was administered by an uncertified officer or that the machine was outdated and past its inspection date. However, only the attorney you hire, such as a Orange County DUI lawyer, will be able to make a case regarding the inaccuracy of a breathalyzer test.
