When the service auditor is satisfied with the organization, the service auditor renders what is referred to as an unqualified opinion. Though a Statement on Auditing Standards (SAS) No. 70 audit is technically not a pass or fail audit, the

receipt of an unqualified opinion from the service auditor is usually assumed to be as passing the audit.
