Additionally, in Pennsylvania, if a driver is less than 21 years of age and is driving a vehicle with a blood alcohol concentration level that is more than 0.02%, he/she can be charged with driving under the influence of alcohol.

Now that you are familiar with what qualifies as drunk driving, let's take a look at some of the other highlights of a case associated with such an offence:

Figures show that Pennsylvania recorded 496 cases of drunk driving fatalities in 2008. In fact, drunk driving comprised 34% of all vehicle accident-related fatalities in Pennsylvania alone.
